Other: Cool regrind before placing in containers to prevent decomposition. Under

abnormal conditions (equipment malfunctioning, etc.), decomposition may occur resulting in fumes which will contain the combined vapors and odors from all ingredients. Use HIOSH-approved respirators when removing

decomposed material.

Eye Protection: Use of safety glasses is recommended during processing.

Protective Glove: Rubber, worn when cleaning condensate from exhaust hood/other surfaces.
